

## Agenda Item 12: To consider requests for donations

#### Request 1: Parenting Special Children

Parenting Special Children (PSC) is a small Berkshire based charity set up over 16 years ago to provide specialist support to families of children and young people with a whole range of special needs and disabilities, including early life trauma across Berkshire. We celebrated our 15th birthday last year and were delighted to welcome The (then) Countess of Wessex to a special reception in Reading Town Hall.

The families we support care for children who face complex challenges, disability, neurodiversity, physical and mental health diagnoses, neglect, abuse and other adverse childhood experiences. Last year, we supported more than 2500 families and professionals working with them.

I have attached a copy of our Annual Review 2022, which shares the highlights from our year, and the differences we've made for the families and children we've worked with across all our groups.

Families are really struggling at the moment from the aftermath of the Covid pandemic followed by the cost of living crisis. At the same time, this financial year is proving more challenging than ever before in terms of fundraising for all charities, and PSC is no exception.

At the moment, we're focussing our fundraising efforts around our vital Community Support Groups. In response to many requests from parents/carers across the County, we set up a number of monthly groups which provide ongoing support for families with children and young people with Special Educational Needs or Disabilities. Alongside 3 geographically based general groups, we also set up specialist groups for Kinship Carers, Adopters, and for Dads and Male Carers. These groups provide parents/carers with mutual practical and emotional support, alongside specialist information and advice, and help to reduce feelings of isolation experienced by many of our families.

Comments like this from P help to demonstrate the difference the group can make: "I honestly don't know what I would do without this group. I have no family locally and no real friends. I came to this group as advised by my school and I have never looked back. I now have a safe space where people just get me and my children. I am not judged and I now have a group that has been a lifeline for me."

We would love to partner with West Ilsley Parish Council to continue to deliver our Community Support Groups for families across Berkshire by making a donation? Each group costs approximately £500 per month (£6,000 per year) to deliver, and any contribution you can offer to help us continue these groups at this challenging time will be greatly appreciated.
